INTENT: This Addendum forms a part of the Contract Documents and modifies the original

Bidding Documents and Prior Addenda if any, as identified above.

#### **VENDOR QUESTIONS:**

**Question 1:** Are the monthly inspections to be just a visual?

**Response:** The fire extinguishers must be inspected, maintained, tested, and serviced as per the National Fire Protection Association (NFPA) standard. The requirements are detailed in NFPA 10, Standard for Portable Fire Extinguishers.

**Question 2:** Clarify Annual Maintenance.

**Response:** The fire extinguishers must be inspected, maintained, tested, and serviced as per the National Fire Protection Association (NFPA) standard. The requirements are detailed in NFPA 10, Standard for Portable Fire Extinguishers.

**Question 3:** Is July to be the month that they are tagged during the monthly?

**Response:** The annual maintenance, and tagging, of all fire extinguishers is expected to be completed during the month of July each year.



**Question 4:** Is the cost of the monthly and the annual maintenance & tagging to be combined and put as the total cost on the cost sheet in the first column under **ANNUAL MAINTENANCE** & **TAGGING.** 

**Response:** The annual maintenance and tagging will be conducted in July, as such the monthly inspection is only required during the remaining 11 months (August through June)

#### **CLARIFICATIONS:**

- 1. A large portion of the College's stock of fire extinguishers were purchased recently. To create a more consistent budget year to year, the 6-year maintenance and/or hydrostatic testing may be requested to be conducted earlier than otherwise required, for a certain number of fire extinguishers. The goal is to have about 1/6 of the entire stock due for the 6-year maintenance or hydrostatic testing each year.
- 2. If requested by the College, the Vendor shall provide information about compliance requirements and best practices. Such as, locations that currently have a fire extinguisher where one is not required or locations that are missing a required fire extinguisher of a particular size or type, based on the particular hazard. This may include kitchens, vehicles (including golf carts or similar), or other locations throughout the campus.

## UPDATED COST SHEET TO INCLUDE ADDITIONAL SCOPE OF WORK WHICH INCLUDES STORAGE OF SPARE FIRE EXTINGUISHER INFORMATION AND COST.

1. Vendor shall indicate on the updated cost sheet, if they can provide storage for TCNJ-owned spare fire extinguisher at their location, and if there is a cost associated with this. The Vendor will use this stock to swap out any fire extinguishers, as is necessary, at TCNJ. The Vendor will maintain this stock of fire extinguishers in a current state of readiness (i.e. tagged, inspected monthly, and current with any service/maintenance requirements (e.g. 6-year maintenance, hydrostatic testing, etc.), etc.). The Vendor will not otherwise use these fire extinguishers for any other purpose than to fulfill the scope of the TCNJ contract. TCNJ will maintain a portion (about 30 fire extinguishers) of its spare stock on campus. Please be sure to include the revised Cost Sheet with your bid submission.
